HAPPY NEW YEAR! Panel 74's first year of this rotation is officially in the books. What a whirlwind! Every day, every week, and every month presented new learning experiences and incredible opportunities for growth in character building humility. Personally, I am amazed by the spiritual growth that I have experienced. What a blessing! I am incredibly grateful! I have been busy wrapping up the month of December and the 2024 fiscal year preparing reports and presentations for both the upcoming Finance Committee Meeting on Thursday January 9th, and the Quarterly next week.

The total income received in December was \$4,377.44 and the total expenses were \$5,042.33. We ended the month with a (\$644.89) net loss for December. Fiscal year 2024 ended with a net loss of (\$1,584.84). We hoped to end the year with a net gain, not a loss, but on a positive note, our net loss for 2024 is a huge improvement compared to the 2023 net loss of (\$11,993.16). The 995 Challenge certainly helped with an additional \$2,510.47 that we otherwise would not have had!

We are heading in the right direction. If we stay united and work together to support the work of Washington State East Area 92 with our contributions, our resolute trusted servants will have all they need to reach the still suffering alcoholic, as we are called to! United we can accomplish all of our goals, so it makes sense that Unity is our First Tradition!

I have the God of my understanding and Alcoholics Anonymous to thank for my recovery and I have all of you to thank for the opportunity to serve as your Area 92 Treasurer! For that I thank you! See you in Selah!

Kevin, if you happen to read this, I suspect it will transport you back to this moment with pen in hand.

"To our valued fellow A.A.s,

Hi, I am Kevin and I'm an alcoholic. The reason I write this to you is to let you know how your 12 th Step work is positively affecting not just my life, but dozens inside the walls here at Coyote Ridge Correction

Center. Your efforts at attending our meetings, or supporting us with literature and books, allows us to be on the right path in sobriety.

Drugs and alcohol are available in prison. So is a meeting. We have Monday evening meetings with more than 30 people present, and Saturday a.m. meetings where 12-20 usually attend. At each of these we have literature, Big Books, 12x12's, and Daily Reflections or As Bill See's It, all set out for anyone to take. Oh, and Grapevine also, both in Spanish and English. Each Monday two of our Religious Activities Center employees do a book run where unused books, including those listed above, are brought back into circulation for those in need.

Right now, I'm sitting in a meeting about to start. The books you have donated are all around the room.

One of you is here with us so that this meeting will be able to take place. In short, you have helped us change our lives in sobriety, and we thank you.

Committees. Her passion is more around the internet & public information so that is the perspective and experience she brings to the committee. She's prepared by researching all things CPC.

While the AA fellowship sets the agenda for the committee, they can discuss other topics that arise. She is under 30yo and social media has always been a part of her life. Alex defines social media as online platforms that help us engage with the outside world. Oftentimes social media is used to promote a product to educate us, to help us understand in an engaging way: ideas, concepts, etc. She has insights for our AA accounts that can boost viewing and sharing. Alex asked the head of social media for Adobe to assess the existing platforms used by A.A. and provide professional feedback. Alex shared those comments/information with AA during the conference committee, no suggestions were taken. AA moves slower than social media, so AA's current online presence is archaic.

She believes there is a way to engage with the platforms, but it requires people with knowledge and experience to do so. In the social media world, our AAWS LinkedIn page has poor engagement: ex. 4,175 followers but only engaging 31. There are simple fixes that could correct the problem:

- 1) the videos are too long: no one is watching a video over 30 seconds
- 2) Links to pictures/videos should be clickable and take you to another destination
- 3) It's an English-based platform, so only use English
- 4) The text should take no longer than 2 minutes to read (50 to 200 characters is ideal).

Neither the internet nor AA.org is an easy place for professionals to find answers - especially when they do not know what CPC is. Many searches are done by a spectrum of professionals that AA doesn't appear in the results, i.e., teachers, doctors, nurses, lawyers. When looking for answers, they want something bite-size: they are busy and want something they can easily pass on. We need to be creative in providing this.

At conference, they spoke about modifying the existing meeting guide app to educate the professional - with short, relevant, and shareable information. She will be pushing the Trustees on the following items on January 6:

- 1) Developing hard-copy service materials for distribution to professionals. If your local area has examples, please pass them on to her.
- 2) Rescripting CPC videos that are 30 seconds long
- 3) Committee is against creating another pamphlet! Infographics may be an alternative because it can be shared. ***

Australia's website is amazing with the ability to chat with people who visit (shared by PI). There are flyers in this newsletter with a couple different looks for your audience.

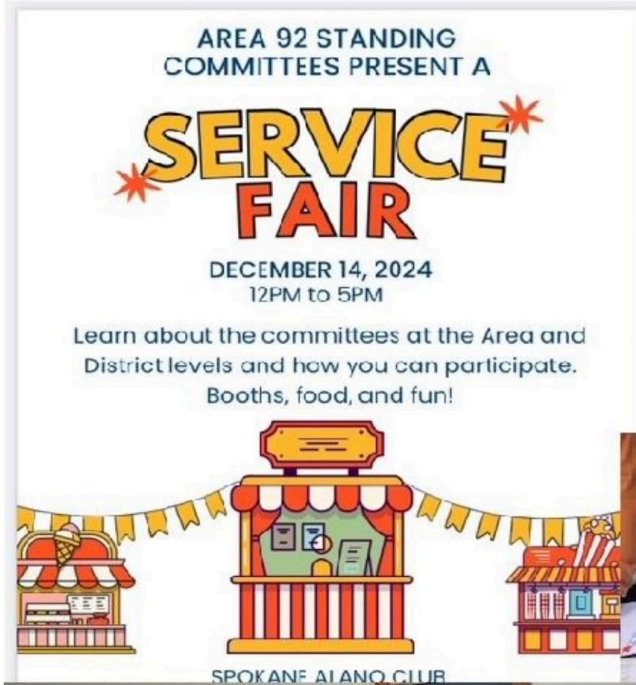

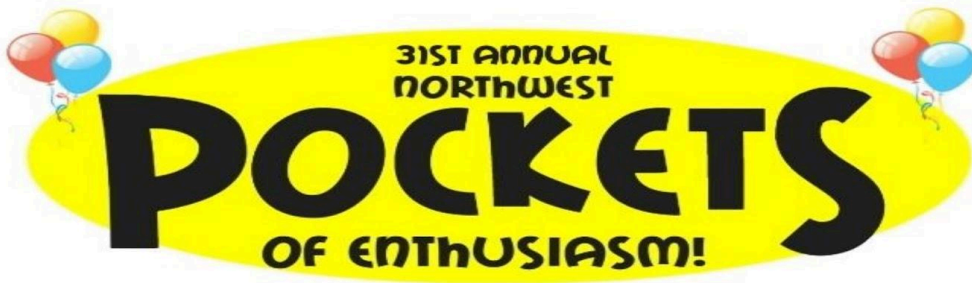
